

Input from the Community Survey


Gathering input from community, including transit customers and residents who do not use the service, is an important part of the initial phase of updating the Transit Development Plan (TDP). From October 24 through November 14, 2022, a short survey asking questions about travelers' use of transit, perceptions of Bis-Man Transit service and basic information on survey respondents was available to complete. Key responses from the survey are shown in the next section.


Who Completed the Survey

Bis-Man Transit History

Bis-Man Transit began service in 1987, as a non-profit corporation providing door-to-door (demand response) service. The initial purpose or goal of the organization was to identify, promote, coordinate and establish transportation service for seniors and individuals with disabilities to provide trips to work, medical appointments and to support recreation travel.

Fixed route service was added in 2004; branded with the State of North Dakota as Capitol Area Transit (CAT).

Service is planned and managed by the Bis-Man Transit Board, which includes up to nine members, each serving a three-year term.

Community Survey (Cont.)

Agree/Disagree with Statements

Survey respondents were asked about their level of agreement/disagreement with a series of statements about transit service in general and their feelings about Bis-Man Transit service.

It is important for the community to provide transit: **91%** respondents Strongly Agree or Agree

Transit contributes to the economic health of the area: **70%** Strongly Agree or Agree

Transit contributes to the local quality of life in the area: **76%** Strongly Agree or Agree

Current service meets my daily travel needs: **43%** Disagree or Strongly Disagree. **31%** Agree or Strongly Agree

It is easy to get to places I need/want to using transit: **36%** Disagree or Strongly Disagree, while **27%** Agree or Strongly Agree

Transit Service Information

Transit service in the community includes two types of service:

- Fixed Route: Buses run continuously over the service day (7:00 AM to 7:00 PM Monday through Friday and 8:00 AM to 7:00 PM Saturday) on a preset route. Riders can get on/ off at any safe location along the route.
- Paratransit: Shared ride service for individuals with a temporary or permanent disability that does not allow them to use fixed route service. In the Bismarck, Mandan and Lincoln area, the service is expanded to include persons 70 years

Below are key statistics associated with current service:

56,700 2021 Annual fixed route rides

86.200 2021 Annual paratransit rides

26.7% FIXED ROUTE - average monthly rides increase each month in the last year over the same month in the previous year

15.1% PARATRANSIT - average monthly rides increase each month in the last year over the same month in the previous year

\$1.7 Million 2021 fixed route operating cost

\$2.1 Million 2021 paratransit operating cost
